### **NOTIFICATION OF CHANGES IN THE SHARE OF THE TOTAL NUMBER OF VOTES IN THE COMPANY UNDER THE BUSINESS NAME OF PRZEDSIĘBIORSTWO PRZEMYSŁU SPOŻYWCZEGO PEPEES S.A.**

Acting in conjunction with Article 69(2)(1)(a) the Polish Act of 29 July 2005 on Public Offering, Conditions Governing the Introduction of Financial Instruments to Organised Trading, and Public Companies (i.e. Journal of Laws of 2025, item 592), (the "Act"), Epsilon Fundusz Inwestycyjny Zamknięty Aktywów Niepublicznych, with its registered office in Warsaw, entered in the register of investment funds maintained by the District Court in Warsaw, 7<sup>th</sup> Civil and Family Division, Register Section under RFI number 1000 (the "Fund"), represented and managed by Origin Towarzystwo Funduszy Inwestycyjnych Spółka Akcyjna, with its registered office in Warsaw, address: ul. Zielna 37, 00- 108 Warszawa, entered in the Register of Entrepreneurs of the National Court Register maintained by the District Court for the Capital City of Warsaw, 12<sup>th</sup> Commercial Division of the National Court Register under KRS: 0000294964, NIP: 108-00-04-198, REGON: 141186082, with the share capital of PLN 3,690,100.00 paid in the amount of PLN 3,417,700.00 ("Towarzystwo"), would like to hereby announce a reduction in the Fund's shareholding in the share capital of Przedsiębiorstwo Przemysłu Spożywczego PEPEES S.A., with its registered office in Łomża at ul. Poznańska 121 Łomża, entered in the Register of Entrepreneurs of the National Court Register maintained by the District Court in Białystok, 12<sup>th</sup> Commercial Division of the National Court Register under KRS:0000038455, NIP: 7181005512, REGON:450096365 (the "Company"), resulting in a reduction of the Fund's share below the threshold of 5% of the total number of votes in the Company.

#### 1. Information pursuant to Article 69(4)(1) of the Polish Act

The change in the Fund's existing share in the total number of votes in the Company occurred as a result of a transaction for the sale of shares in the Company conducted on the regulated market on 8 May 2025 and settled on 8 May 2025.

#### 2. Information pursuant to Article 69(4)(2) of the Polish Act

Prior to the change in shareholding, the Fund held 27,759,032 shares in the Company, representing 29.22% of the Company's share capital and entitling it to 6.69% of the votes at the Company's General Meeting.

6. Information pursuant to Article 69(4)(7) of the Polish Act


The Fund does not hold, directly or indirectly, any financial instruments referred to in Article 69b (1) of the Polish Act.
