NOTIFICATION OF DISPOSAL OF SHARES

with its registered office in Łomża (hereinafter: "PEPEES S.A.")

Acting pursuant to art. 69 (1) (2) of the act of 29 July 2005 on public offering and on the conditions for introducing financial instruments into organised trade systems and on public companies (consolidated text of 28 June 2013, Journal of Laws of 2013, item 1382), TRADO - GPT Spółka z ograniczoną odpowiedzialnością Spółka komandytowa (former: TRADO Spółka Akcyjna) with its registered office in Warsaw (hereinafter: "Company"), we hereby inform that due to the Company's disposal - on the basis of the Financial Instrument Sale Agreement of 9 March 2016 - of all shares held in the share capital of PEPEES S.A. for the benefit of Mr Michał Maksymilian Skotnicki, the Company's interest in the share capital and total number of votes in PEPEES S.A. have changed.

Before the abovementioned transaction, the share package held by the company (8 600 000 bearer shares of series A) constituted 9.05 % of the share capital, which amounted to 9.05 % of the total number of votes.

As a result of the disposal of all shares in the share capital of PEPEES S.A. held by the Company, i.e. 8 600 000 bearer shares of series A, the Company currently holds no shares in the abovementioned publicly listed company and has lost its entire share in the total number of votes in PEPEES S.A.

At the same time, pursuant to art. 69 (4) (5 and 6) of the act of 29 July 2005 on public offering and on the conditions for introducing financial instruments into organised trade systems and on public companies (consolidated text of 28 June 2013, Journal of Laws of 2013, item 1382), the Company informs that it is a subsidiary of Mr Maciej Grabski.
